14:00 Panel session 1 – Current Trends in a Larger Pan Europe: Synergies, Conflicts and Solutions

Neighborhood Policy, European Commission)

This panel will focus on the economic issues, trade, security and geopolitical trends, all in the *Pan Europe context*, including European Union (EU) and Eurasian Economic Commission (EEC) Countries and the Ukraine.
