# The Concept

In August 2013 IIASA and EFA jointly launched the Alpbach-Laxenburg Group (ALG), a reflection group with the capacity to draw together some of the world's finest intellects and put them to work on selected problems of global change. Both IIASA and EFA have broad and influential networks that span a large range of human activities from science across business and diplomacy to the fine arts. ALG is working to harness and synergize those talents to the benefit of humanity and the environment on which we depend.

ALG is all about perspectives, swapping them, finding commonalities and disagreements. "Great minds" do not always "think alike." As the ALG has already shown, probing the similarities and the differences between viewpoints can be a fertile ground for new discoveries. A scientist can learn from a dancer, a policymaker from a businessperson.

#### ALG 2015

The first ALG retreat with its focus on finding solutions to inequality in education, energy access, and financial systems, was an excellent preparation for tackling the upcoming ALG theme of the Sustainable Development Goals (SDGs).

The transformation to sustainability covers much ground: energy transitions, climate change, atmospheric pollution, world population, food and water, poverty and equity, social justice, world financial and monetary structures, and strategies around the future of the key geopolitical hotspots.

ALG participants comprise men and women who, independent of national or financial interests, are willing to place their collective knowledge, expertise, experience, and reputation at the service of the world community at this critical period in Earth's development.

All the participants are aware, from their different standpoints, how difficult it will be to implement and achieve the SDGs. Adopting sustainable best practices, public acceptance, ensuring compliance with new regulations—we can see, even at this early stage, that the road ahead is fraught with difficulties. Competition for the same economic and financial space will likely go hand in hand with conflicting ideologies and incompatible approaches.

The reflections of this meeting of the ALG is to develop positive narratives on sustainable development. IIASA ensures that our work benefits by sound research, grounded in cutting-edge systems analysis. The EFA ensures that our ideas and conclusions are passed on to a wider international audience, including the general public.

- 1. Taking an honest look at the past experience, how can the SDGs really contribute to a sustainable transformation? What is missing to make transformation a reality? Are we perhaps, despite our good intentions, beating a dead horse and not giving enough space to possible intergenerational abrupt and disruptive developments which could in fact be solutions? Are our solutions perhaps a generation behind? How far can we get with established methods and should we expect smooth transformations or disruptive processes?
- 2. Research has shown the huge benefits of moving from silos to more integrated and systemic approaches in science, policy, and financing, among others. Yet this potential is hardly being used. For example, many of the 17 SDGs will be competing for the same economic and financial space and there is currently no articulated strategy on how to benefit from a joint implementation and financing of the SDGs and climate goals.

## The IIASA and EFA Partnership

Since its establishment in 1972 IIASA has been a natural convener of international science to policy dialog and collaboration, due to its research emphasis on integrated systems analysis to address human and environmental concerns. It is therefore well placed to host a new generation of think tank that is not only dedicated to finding the most effective means to manage global transition to sustainable development, but also capable of effectively communicating these to policymakers and to the public at large. This quality has been enhanced by IIASA's recently established close collaboration with the European Forum Alpbach.

IIASA has several major advantages. It is governed by its 23 National Member Organizations (NMOs) from developing and developed countries alike. As well as providing support to the Institute, NMOs bring IIASA senior scientists into daily contact with high-level scientists and policymakers from many countries and organizations.

In the course of its scientific research, IIASA has established a network of over 350 partners from the international community, academia, business, and policy. Every year since 1945, the "European Forum Alpbach" has been held in the Tyrolean mountain village of Alpbach. For almost three weeks Alpbach becomes the village of thinkers or, as Otto Molden, the founder of the Forum, called it, the "other magic mountain." Speakers and participants from all parts of the world, from science, economics and politics, experienced experts and students, come together in Alpbach to discuss current issues and to formulate interdisciplinary solutions. The open character of the events promotes a climate of tolerance for different opinions and contributes to the overcoming of national, ideological and disciplinary boundaries in a harmonious way. Every year, more than 4,000 people from over 86 countries take up the invitation to participate in the European Forum Alpbach, among them some 700 young scholarship holders from all over Europe and beyond.

IIASA's systems approaches and its scientific excellence, combined with the Forum's unique and historically proven power to convene meetings with leading political, economic, and industrial players, thus provides an extraordinary platform for interdisciplinary dialog.

The European Forum Alpbach and IIASA are both uniquely poised at the nexus of international and interdisciplinary research to seek solutions to major global challenges—such as energy, climate, food and water, poverty and equity, and their related issues on the economic and political governance. The hosting of a new think tank to support solutions of persistent world problems is entirely in line with the internal aims and policy of both organizations.
